4. The participant acknowledges that they are responsible for their own safety and the safety of others whilst partaking in the activities. They understand that the activities maybe undertaken without direct supervision following safety instructions and agree at all times to ensure that they wear any protective equipment provided by the Dojo and to ensure that they comply with any instructions given at any time during the activities by dojo instructors and dojo leader.

5. The participant warrants that they will only carry out moves and cuttings that are within their ability level and of which they are able to retain control of at all times. Moves and cuttings are performed at the participants own risk.

The participant warrants that they do not have any medical condition or have not had a medical condition which may make them partaking in the activities dangerous, increase risk of injury to them or others, or make it more likely that they will be involved in an incident which could result in injury during the activity.

7. The participant acknowledges that the Dojo is not liable for damage or loss of any personal belongings and properties during activities.

8. The participant expressly agrees and promises to accept all risk existing and subsisting in the activity and acknowledge that their participation in the activity is voluntary and that they elect to participate despite of the risks. The participant releases and agrees to indemnify the Dojo, together with its equipment suppliers and manufacturers, from any and all claims demands or courses of action which are in any way connected with the participation in the activities.

9. I agree that this waiver shall apply to all visits within the next 60 months from today's date and I will not be required to sign a fresh copy of this waiver before each visit.
